Tee Times Tee times for Summer Passholders can be made up to 14-days in advance.

Discounts Summer Passholders receive a 10% discount on all merchandise. Special food and beverage pricing is also available. Please ask an associate for details.

Range Balls Summer Passholders receive \$100 in complimentary range balls.

Golf Carts Golf carts may be required prior to 12 P.M. Thursday - Sunday for pace of play purposes.

Walking Policy Summer Passholders may walk at no cost all day Monday - Thursday or after 12 P.M. on Friday - Sunday.

Cancellation Policy All tee times must be cancelled 24-hours in advance. Any tee time not cancelled may result in loss of pre-booking privileges. Charges may be applied to your credit card. Repeat non-cancellations may result in termination of your Summer Pass.

Fivesomes Fivesomes must be pre-approved.

Dress Code Golf attire is required when playing golf or using the driving range.
